

International Programmes for Clients Around the World

Nigeria


Since 2015 EPC has worked through the British High Commission in Abuja, Nigeria, to deliver a series of events in support of the Nigerian Government, training has taken place both in the UK and in-country. This work started at the highest Strategic levels and is now continuing into a longer-term programme of capacity building in a range of areas.

These have included:

- Training in Crisis Response Doctrine
- Crisis Management & Counter Terrorism Response
- National Risk Management
- Helping to draft national doctrine and embedding it within national structures
- Training of the Nigerian equivalent of the UK COBR with an element of knowledge transfer through 'Train the Trainer' input
- Joint Operations Centre training operation and management

British Overseas Territories

During 2018, in the aftermath of Hurricanes Irma and Maria, EPC assisted in the research, development and drafting of a Concept of Operations (CONOPS) document for disaster management in the Caribbean Overseas Territories, with a specific focus on how UK Government departments such as the Ministry of Defence, Department for International Development and the Foreign & Commonwealth Office work with Overseas Territories Governments, Governors and their offices, alongside disaster management personnel and other teams, international agencies and regional actors including the Caribbean Disaster Emergency Management Agency. In addition, EPC designed and facilitated two exercises, one in Miami and another in London to evaluate and discuss the processes and procedures.



Morocco

At the request of the JOPP Security Coordinator the EPC delivered a workshop to the Ministry of Interior (MOI). The purpose was to conduct a workshop with strategic emergency management leadership in order to explore the development of a strategic statutory and doctrine framework for the management of civil emergency from planning to response and recovery, drawing on the UK experience of Integrated Emergency Management and the JESIP Principles. The workshop revolved around a series of inter-connected lectures, exercises and discussions that covered the following areas:

- The UK Approach to Resilience
- Integrated Emergency Management (IEM)
- UK Concept of Operations (CONOPS)
- UK Doctrine
- CONTEST Policy
- Civil Contingencies Act 2004
- Joint Emergency Services Interoperability Programme (JESIP)



A Gulf Client contracted the EPC to deliver a best practice Quality Review of the their Resilience Management (RM) System in September 2018.

Our Base Line Review model was based on five themes:

- Review all components of RM Model: Risk Management, Business Continuity Management, Audit Planning and Leadership and Oversight, in light of standard practices.
- Conduct survey/interviews to assess the awareness, maturity and currency of RM.
- Identify areas of improvement (gap assessment).
- Recommend gap closure strategies and actions.

This is a typical task for the EPC which was conducted in 5 working days.



Indonesia

In October 2018, the EPC was tasked to develop and deliver a strategic-level workshop with an aim to assess Indonesia's current response methods and compare to the UK approach.

 The high-level workshop involved a cross-government audience including the National Disaster Management Authority (BNPB), the CT Authority (BNPT), National Police, the President's Office and the Coordinating Ministry for Political, Legal and Security Affairs and MOI.

• The EPC produced a detailed report on areas identified that could benefit from further elaboration of the UK's approach to resilience.

This is a typical task for the EPC which was conducted in 5 working days.
